During the financial year ended 31 March 2025, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2024/25 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. ### Response to Internal Control Objectives securing a 'No' return

Control Objective	
B	VAT records are incomplete following the dissolution of the Council in 2023. No payments were made from the Council account until March 2025 so any VAT return will be completed in the 2025/26 financial year.
D	No payments were made in the year so the budget was unaffected. This should have still been completed and the first report for 2025/26 will be presented at the July 2025 Council meeting.
I	No payments were made from the bank account due to not being able to access online banking. Therefore there was nothing to reconcile until March 2025 which was completed.
K	The Council met the criteria and the paperwork was prepared but it wasn't presented to Council to approve or displayed on the website.
L	Issues with accessing the website used by the dissolved Council resulted in a temporary one being set up which was not properly updated during the year. Council have now set up a new website with a recognised provider and it is being progressively updated
M	The period for the exercise of public rights was not displayed on the Council website.
N	Publication requirements were not met but the website is being updated with all the required documents.
